


Definitions

- Light-Duty < 6,000 lbs. GVWR
 - Passenger Vehicles, Light-Duty Trucks, SUVs, Motorcycles
 - Natural Gas, E85, Gasoline, Diesel
 - Hybrid, Electric, PHEV, Fuel Cell
- Medium-Duty 6,000 lbs. < GVWR < 14,000 lbs.
 - MD Trucks
 - LHD Trucks
 - Natural Gas, E85, Gasoline, Diesel

Sources and Emissions


- Passenger Vehicles Account for About 23 percent of ROG; 20 percent of NOx; and 11 percent PM2.5 emissions in the South Coast AQMD
 - Passenger vehicles include: cars, light trucks, SUVs, minivans, motorcycles

Major Contributors to NO_x (2014)




2014 NOx - 650 tpd

- Accelerated Fleet Turnover
- On-Board Diagnostics

In-Use Emissions

- Reducing In-Use Emissions Critical
- How To Effectively Accelerate Vehicle Turnover?
- SIP Commitments for South Coast in 2014:
 - AQMD High Emitter Repair or Scrap (HEROS)
 - 1.4 TPD ROG

- 0.9 TPD NOx
- State's Expanded Vehicle Retirement Program
 - 2.8 TPD ROG
- 2.4 TPD NOx

AB 118

- Current BAR Program Goal is to Scrap About 18,000 Cars per Year
- Proposed Program Through AB 118
 - SCAQMD Additional 50,000 vehicles per year
 - SJVAPCD Additional 10,000 vehicles per year
 - Failing and passing vehicles are eligible
 - Higher per vehicle incentive
- Potential Reductions of 2.8 TPD ROG and 2.4 TPD NOx in South Coast in 2014

AB 118

- Retired vehicle to receive voucher for purchase of "newer" vehicle
- Replacement Voucher Program for Vehicle Replacement Focused in South Coast and San Joaquin Valley
- Administered by ARB Beginning in 2010
- Administered through local air districts

AB 118

- Target:
 - Pre-1976 vehicles
 - Eligibility determined via BAR database (age, history)
- \$2,000 Base Voucher for Replacement with Newest Four Model Years
- Purchases through commercial car dealerships
- \$500 Additional for Income-Eligible Replacement with Newest Ten Model Years
- Replacement "Voucher" Program
 - South Coast 2,500
 - San Joaquin 500
