BACKGROUND

This report summarizes the activities of the Legislative, Public Affairs and Media Office for June and July 2019. The report includes: Major Events; Community Events/Public Meetings; Environmental Justice Update; Speakers Bureau/Visitor Services; Communications Center; Public Information Center; Business Assistance; Media Relations; and Outreach to Community Groups and Governments.

MAJOR EVENTS (HOSTED AND SPONSORED)

Each year South Coast AQMD staff engage in holding and sponsoring a number of major events throughout the South Coast AQMD's four county areas to promote, educate and provide important information to the public regarding reducing air pollution, protecting public health, and improving air quality and the economy.

June 30

Staff exhibited at the CicLAvia–Mid City Meets Pico Union event in Los Angeles. This event focuses on active and alternative forms of transportation and attracts thousands of attendees with interests in health and environmental issues. Staff provided information on South Coast AQMD, AB 617, environmental justice, residential incentive programs, South Coast AQMD mobile apps and various other programs.

COMMUNITY EVENTS/PUBLIC MEETINGS

Each year South Coast AQMD staff engage with thousands of residents, providing valuable information about the agency, incentive programs and ways individuals can help reduce air pollution through events and meetings sponsored solely by South Coast AQMD or in partnership with others. Attendees typically receive the following information:

- Tips on reducing their exposure to smog and its health effects;
- Clean air technologies and their deployment;
- Invitations or notices of conferences, seminars, workshops and other public events;
- South Coast AQMD incentive programs;
- Ways to participate in South Coast AQMD's rules and policy development; and
- Assistance in resolving air pollution-related problems.

South Coast AQMD staff attended and/or provided information and updates at the following events:

<u>June 7</u>

Staff participated in the Today's Fresh Start Charter School Career Day 2019 event in Los Angeles to provide students with information on potential career paths related to air quality issues. Staff also provided information on the South Coast AQMD programs and resources.

June 20

Staff exhibited materials on South Coast AQMD and air quality issues at the Western Riverside Council of Governments General Assembly in Temecula. Information on incentive programs for mobile sources, residential and commercial electric landscaping equipment, and clean air furnaces was provided to attendees which included elected officials, businesses and other stakeholders.

<u>June 22</u>

The Governing Board Refinery Committee held a community meeting at the South Coast AQMD headquarters in Diamond Bar to discuss hydrogen fluoride storage and use at petroleum refineries. The meeting was attended by almost 500 members of the community, business stakeholders, and environmental and health organizations.

June 25

Staff exhibited at the Sustain SoCal Driving Mobility Conference held at the University of California, Irvine. Staff provided information on South Coast AQMD and air quality issues, including mobile sources, incentive programs and other related initiatives.

<u>June 26</u>

Staff held an AB 2588 Toxic Hot Spots public meeting related to the Grayson Power Plant in Glendale. The meeting included a staff presentation on the AB 2588 program and Grayson Power Plant, as well as public comment and questions. The meeting attendees included elected officials, government representatives, community members, and business representatives.

June 30

Staff participated in the Annual St. Andrews Park Community Jazz Festival in Los Angeles to provide community members with information on South Coast AQMD and air quality issues. The focus was on providing information related to residential incentive programs, how to file an air quality complaint, and the South Coast AQMD mobile apps.

July 3

Staff exhibited at the Good Morning Event in Ontario to provide representatives from local elected offices and business stakeholders with information on South Coast AQMD, Clean Choice Vehicles, incentives, Small Business Assistance and other programs.

<u>July 24</u>

Staff exhibited at the Orange County Business Council 2019 Health Care Forum in Newport Beach to provide information on South Coast AQMD and air quality issues. The focus was on providing information regarding business and residential incentive programs, and South Coast AQMD mobile apps.

ENVIRONMENTAL JUSTICE UPDATE

The following are key environmental justice-related activities in which staff participated throughout the months of June and July 2019. These events involve communities affected disproportionately from adverse air quality impacts.

<u>June 5</u>

Staff hosted the third community identification meeting for the AB 617 program in the City of Huntington Park. Staff presented information on the community prioritization process and shared details about an upcoming information fair. The meeting was attended by community members, local organizations, as well as representatives of local elected officials.

<u>June 6</u>

Staff participated in the 6th Annual Fighting for Life Celebration hosted by East Yard Communities for Environmental Justice. The event honored three community leaders: 1) Evelyn Knight, a long-time civil rights and environmental justice leader; 2) Mooney D'Arcy, Executive Director at Sacred Places Institute for Indigenous Peoples; and 3) Candice Kim, Climate Campaign Director at the Center for Biological Diversity.

<u>June 12</u>

Staff hosted the second Inter-Agency Task Force meeting in partnership with the Los Angeles Bureau of Sanitation. There was a total of 28 representatives in attendance from Los Angeles-based public agencies and community organizations. New participants included Pacoima Beautiful and the Los Angeles County Department of Public Health. The Task Force discussed appropriate use of terminology in the complaint process, inter-agency staff training, and expanding and distributing an inter-agency referral directory.

<u>June 13</u>

Staff held the seventh AB 617 Community Steering Committee meeting for the Wilmington/Carson/ West Long Beach communities in Wilmington. The meeting included presentations by Committee members including the Port of Los Angeles, Long Beach Alliance for Children with Asthma, and Coalition for A Safe Environment. A presentation was also provided on the AB 617 Technical Advisory Group. The main topic of discussion was the draft Community Emissions Reduction Plan.

<u>June 19</u>

Staff held an AB 617 community identification meeting in Jurupa Valley to discuss the community prioritization process and opportunities to help reduce air pollution in environmental justice communities.

June 20

Staff held the seventh AB 617 Community Steering Committee meeting for the San Bernardino/Muscoy communities at San Bernardino Valley College. The meeting included presentations by Committee members including BNSF, San Bernardino County Land Use Planning, and Loma Linda University. There was also a presentation by the AB 617 Technical Advisory Group. Discussion included the draft Community Emissions Reductions Plan and establishing goals. Additionally, CARB presented information on enforcement actions to address air quality issues in the community.

<u>June 22</u>

Staff exhibited at the Health Communities Resource Fair, which was hosted by the Long Beach Alliance for Children with Asthma, at Admiral Kidd Park in Long Beach to provide community members with information on South Coast AQMD, air quality issues, how to file an air quality complaint, and incentive programs available to residents.

June 25 and 26

Staff held two community meetings on Rule 1180 Refinery Fenceline Monitoring in Wilmington and Torrance. The meetings were attended by community members, environmental and health organizations, businesses and other stakeholders. Staff presented information on Rule 1180 and the proposed fenceline monitoring plans. Meeting attendees participated in a poster session with staff answering questions related to each refinery monitoring plan, as well as general public comment.

<u>June 26</u>

Staff attended the Congressional Convening on Environmental Justice conference in Washington D.C. hosted by Congressman Raúl Grijalva (D-AZ) and Donald McEachin (D-VA). The focus of the conference was to mobilize support for environmental justice and spur legislative action. Policymakers and a broad range of organizations and individuals participated in panel discussions on a variety of topics, including priorities and challenges for environmental justice organizations. Representatives from community-based organizations from across the nation attended, including East Yard Communities for Environmental Justice, Center for Community Action and Environmental Justice, and the Moving Forward Network.

June 27

Staff held the seventh AB 617 Community Steering Committee meeting for the Boyle Heights/East Los Angeles/West Commerce communities at the Commerce Senior Center. The meeting included presentations by Committee members and a presentation by the AB 617 Technical Advisory Group. The main topic of discussion was the draft Community Emissions Reduction Plan.

<u>July 11</u>

Staff held the eighth AB 617 Community Steering Committee meeting for the Wilmington/Carson/West Long Beach communities at the Wilmington Senior Center. Prior to the start of the meeting, staff held a community workshop with information on incentives, the Community Emissions Reduction Plan, and the Community Air Monitoring Plan. Marathon Petroleum Company, a member of the Committee, presented information on community programs and ongoing monitoring efforts. The majority of the meeting was committee discussion about the draft Community Emissions Reduction Plan.

<u>July 18</u>

Staff held the eighth AB 617 Community Steering Committee meeting in San Bernardino for the San Bernardino/Muscoy communities. Prior to the start of the meeting, staff held a community workshop with information on incentives, the Community Emissions Reduction Plan, and the Community Air Monitoring Plan. San Bernardino County Transit Authority, a member of the Committee, presented information on community programs and ongoing monitoring efforts. The majority of the meeting was dedicated to discussion of the draft Community Emissions Reduction Plan.

<u>July 19</u>

Staff participated in an environmental justice community tour led by Pacoima Beautiful. A highlight of the tour was a viewing of an open-air art installation focused on raising community awareness of air quality issues. Information was also provided on "A Day in the Life" youth program where students take home air monitors, analyze the data, and give presentations on community air quality concerns.

July 25

Staff held the eighth AB 617 Community Steering Committee in East Los Angeles for the Boyle Heights/East Los Angeles/West Commerce communities. Prior to the start of the meeting, staff held a community workshop with information on incentives, the Community Emissions Reduction Plan, and the Community Air Monitoring Plan. The USC Keck School of Medicine, a Committee member, presented information on research efforts and ongoing community engagement. The majority of the meeting was committee discussion of the draft Community Emissions Reduction Plan.

<u>July 25</u>

Staff represented South Coast AQMD at Mujeres De La Tierra's "Telenovelas in the Park" event. The event serves to educate families about various ways to heal "La Madre Tierra" (Mother Earth) including the benefits of driving an electric vehicle to reduce pollution and let "Mother Earth breathe." Mujeres De La Tierra works in partnership with organizations like Pacoima Beautiful and East Yard Communities for Environmental Justice on a variety of environmental justice initiatives.

<u>July 26</u>

Staff hosted the third Environmental Justice Advisory Group meeting of 2019. Staff presentations included, air quality monitoring in San Bernardino and Riverside Counties and an overview of South Coast AQMD media and communications strategies. Committee members provided input on ways South Coast AQMD can engage more low-income communities in monitoring projects.

SPEAKERS BUREAU/VISITOR SERVICES

South Coast AQMD regularly receives requests for staff to speak on air quality-related issues from a wide variety of organizations, such as trade associations, chambers of commerce, community-based groups, schools, hospitals and health-based organizations. South Coast AQMD also hosts visitors from around the world who meet with staff on a wide range of air quality issues.

<u>June 11</u>

Staff presented at the Industry Advisory Council of the Los Angeles County Sanitation District in Whittier. Staff provided updates on technical details related to source attribution, air monitoring and other technical analysis needed to develop air monitoring plans. Information was also provided on the AB 617 program including the Community Emissions Reduction Plans. There were approximately 50 business owners, regulators, and environmental engineers in attendance.

<u>June 13</u>

Staff presented at the Israel American Council at Cross Campus in Santa Monica. The presentation provided information on the South Coast AQMD, air quality in the Los Angeles basin, and ways to reduce air pollution in the area and communities.

<u>June 28</u>

Students and faculty from the Art Center College of Design in Pasadena visited the South Coast AQMD headquarters. Staff presented an overview of South Coast AQMD and air quality issues, including alternative fuels and vehicles. The visit also included a tour of the South Coast AQMD laboratory, alternative fueling stations, and a vehicle display.

<u>July 18</u>

Staff and a group of summer interns presented an overview of South Coast AQMD, air pollution, public health and things the public can do to help clean the air to youth from the Great Opportunities Youth Organization in San Juan Capistrano.

July 23

Staff presented information to members of the Los Angeles Industrial Environmental Association at Bishop Mora Salesian High School in Los Angeles about the South Coast AQMD and air quality compliance, including regulations, inspections, permitting, and variances for air pollution. There were over 100 environmental professionals in attendance.

<u>July 25</u>

Staff presented to junior and senior engineering students at Cal Poly Pomona University. The presentation provided general background on South Coast AQMD and air quality issues, as well as regulations, permitting, compliance and enforcement.

July 26

Graduate students from the University of California, Irvine visited the South Coast AQMD headquarters. Staff presented an overview of South Coast AQMD, air pollution, clean air technologies, and alternative fuel vehicles. The visit also included a tour of the South Coast AQMD laboratory, alternative fueling stations and a vehicle display.

MEDIA RELATIONS

The Media Office handles all South Coast AQMD outreach and communications with television, radio, newspapers and all other publications and media operations.

Major Media Topics for June

- Ascon Landfill Spectrum News, Fox 11, and the Daily Pilot requested monitoring results and any advisories issued regarding Ascon Landfill. The Daily Pilot and Fox 11 News requested more information regarding South Coast AQMD's role at the site, any monitoring being conducted, as well as any violations issued to the landfill.
- Rule 1407 Paramount Environmental News requested a list of facilities in Paramount which would be subject to Rules 1407 and 1407.1.
- South Coast AQMD App Staff pitched ABC7 on the release of the South Coast AQMD's mobile app on android devices. The resulting story featuring Board Member Delgado aired and was re-distributed and on sister stations in Palm Spring including ABC, CBS and FOX.
- Toxic Emissions Fees The L.A. Times asked if the toxic emissions fees would be addressed at the next board meeting, which the reporter attended.
- Ozone Monitoring The L.A. Times requested a list of monitoring stations used for ozone air monitoring in South Coast AQMD's 38 areas of coverage and how readings are determined in areas with no monitors in the exact area or that have multiple monitors. The reporter also requested inspection statistics.
- Environmental Justice and Modified Hydrofluoric Acid (MHF) A student from Brown University requested permission to film portions of meeting on the use of MHF. The Baton Rouge Advocate, Building Trades Newspaper, L.A. Times, and the Daily Breeze requested information on current regulatory measures, current and proposed rules, and community meetings pertaining to the use of MHF, particularly at the Torrance refinery. The L.A. Times and Building Trades Newspaper attended the Refinery Committee meeting.
- SB 732 The L.A. Times inquired whether South Coast AQMD was still pursuing a ballot measure that would create a sales tax, an action supported by Move LA. Staff clarified that the measure was to create a voter authority district and provided a status update.
- Grayson Power Plant The Blvd. Sentinel requested information regarding the June 26 public meeting regarding the health risk assessment for Grayson Power Plant.

- Legislative Action The L.A. Times requested copies of documents referred to during the Legislative Committee meeting on 6/14/2019, specifically letters expressing concerns on the redirection of Greenhouse Gas Reduction Fund money; and spending sheets organized by category to show intended use of sales tax money.
- Ascon Landfill Spectrum News, Fox 11, and the Daily Pilot requested monitoring results and any advisories issued regarding Ascon Landfill.
- Warehouses and regional pollution The Redlands Community News requested information regarding local warehouses and air pollution statistics.
