#### Dear AQMD Board,

Since the last meeting of September 5, 2024 the Hyperion continues to expose the citizens of El Segundo with noxious odors and H2s. We are wondering what the result was of Montrose re-calibrating the H2S fence line monitors. Although we see that the Northern monitors seem to now be picking up some level of H2S it still does not seem like it is efficient enough. Our fear is that they have re-calibrated it to a level that the Board will feel acceptable but still does not show the true measurement of the exposure. We are also concerned that they will re-calibrate the South monitors to also reflect a lower number at some point. (Please see table that shows samples of the fence line monitor reading of H2s.)

Inspector Haynes indicated that there is a backup monitoring system and had asked why it was not installed when the current monitoring system goes out. Understanding that LASAN pays Montrose. He was told by staff that the management decided to have Montrose come in and make some changes. However the North monitors still shows H2s readings below previous quarter limits and AQMD inspectors can confirm the stench. Our question is who is overseeing Montrose other then LASAN?

We continue to be battered by disgusting rotten sewage odors which the hyperion staff tells us it does not exist when they come to our homes. Some of us wait and watch the hyperion staff when they show up. Some of us have watched them put their H2S monitors by their truck's exaust pipe, put them on top of their hood, and as the attach picture shows, put the monitor behind something like a wall.

LASAN personnel have contacted some residents and told them that they are at the location or are leaving the location. However, residents have also waited and watched the front of their property for over an hour only to see LASAN vehicale pass the location and never stop or just never show up. This makes us question how many of the 0 out of 5 level of odors are actually falsified especially when we can clearly smell it.

During the July 31<sup>st</sup> hearing Joshua Melendez said that 'within 96 hours a written report is sent out to the complainant. It is our understanding that we are suppose to receive a written report from the hyperion regarding our complaint with in a 96 hour window. Please see the fourth attachment which list dates of complaints and dates that reports were received.

Furthermore, in the beginning we were issued a Report of Findings, an actual written log, that was done by Hyperion staff, not the excel sheets that are being created or distributed by Hyperion Community Outreach team. We would like to receive the actual Hyperion Report of Findings to our complaints. In addition we would like to be able to request those Report of Finding to our previous filed complaints.

Residents continue to complain of being woken up in the middle of the night from stench escaping from the hyperion treatment facilities. The headaches and inability to return to a peaceful nights sleep has exceed any reasonable acceptable level of living comfortably in our own homes.

In one of the hearings it was mentioned that they Hyperion conducts quarterly meetings for the community of El Segundo. I would like to point out that the last meeting that was ever held was almost a year ago, December 6, 2023. Tonya Shelton continues to fabricate lies to put the Hyperion in a good light to the hearing board. Most of the things that she has said are deliberately misrepresentations and are beyond little white lies.

I am constantly hearing from my fellow towns people how their lives continued to be upended by Hyperions disgusting and apathetic actions and behavior. How many people must flee the safety and comfort of their own homes for their personal health and safety of their families. How we still endure an exposure that requires continuous visits to our general practitioners, urgent care and emergency rooms. When is enough enough?

Please consider the decision you make and the actions you take. This has gone on longer then many of us even imagined it could and continues to look like the Hyperion and individuals like Tonya Shelton, will continue to spin fables of good deeds when in reality they are stirring up nothing but a pot of stinky witches stew topped with all thing that sound good.

Thank you for your time and consideration of this very serious matter.
