Hi,

The engine hours will be reset at the end of the year, and the Petitioner will not be out of compliance until they exceed 200 hours again in 2025. Switching between the two-three-engine running configurations would give them almost 17 days (8.33 days for a set of three engines) in January 2025.

I suggest the Petitioner request the current variance to end December 31, 2024, and apply again for an early January Regular Variance hearing (file early to give sufficient time for public notice) for the engines to operate beyond 200 hours for the rest of 2025. With the current request, the engines will have no variance coverage to operate if the need arises for emergency operations after March 31, 2025.
