4. GOOD CAUSE: Explain why your petition was not filed in sufficient time to issue the required public notice. (Required only for Emergency and Interim Variances; see Attachment A, Item 4)

The Line Fire started on 9/5/202 and has burned 37,743 acres as of 9/13/2024. Governor Newson declared a State of Emergency for this fire on 9/7/2024. The Line fire has caused a loss of commercial power to Verizon Wireless' cell tower "Snow Valley". The facility's emergency power generator began operating nonstop since that outage in order to keep the facility functional. The generator, with permit number F94141, has a 200 hour annual operating limit.

Utility company Southern California Edison (SCE) has not provided an estimated date of power restoration (ETR) due to the ongoing fire and whether the 200 hour total annual operating permit limit may be threatened.

Since 01/01/2024 until 9/13/2024, the generator has already operated for 168 hours. Due to the quick accumulation of operating hours during ongoing outages and ongoing fire, an ex parte emergency variance petition is being filed now due to the potential to pass 200 hours of operation in only a few days, before Interim and Regular variances can be requested.

Due to public dependence on wireless telecommunications during routine and emergency events, the emergency generator cannot be deactivated.

Even if the applicable generator not pass 200 hours of operation during this single event, the accumulated hours of operation deserve attention. The potential for additional weather-related power outages and PSPS activations still exists.

- 5. THIS ENGINE SHALL NOT BE OPERATED UNLESS ITS EXHAUST IS VENTED TO THE NON-SELECTIVE CATALYTIC REDUCTION UNIT WHICH IS IN FULL OPERATION AND WHICH IS IN GOOD OPERATING CONDITION AT ALL TIMES.
- 6. THIS ENGINE SHALL NOT BE OPERATED WITHOUT THE USE OF AN AUTOMATIC AIR-TO-FUEL RATIO CONTROLLER WHICH SHALL BE MAINTAINED AND KEPT IN PROPER OPERATING CONDITION AT ALL TIMES.

- 8. AN OPERATIONAL NON-RESETTABLE TOTALIZING TIME METER SHALL BE INSTALLED AND MAINTAINED TO INDICATE THE ENGINE ELAPSED OPERATING TIME.
- 9. THE FACILITY SHALL MAINTAIN ACCURATE MAINTENANCE RECORDS OF THE DATE OF CATALYST CLEANING OR REPLACEMENT, OXYGEN SENSOR REPLACEMENT, THE TOTAL HOUR READING ON THE NON-RESETTABLE TOTALIZING TIME METER TO DETERMINE THE ENGINE ELAPSED OPERATING TIME, AND RECORDS OF ENGINE TUNE-UPS.
- 10. AN ENGINE OPERATING LOG SHALL BE MAINTAINED WHICH, ON A MONTHLY BASIS, SHALL LIST ALL ENGINE OPERATIONS IN EACH OF THE FOLLOWING AREAS:
  - A. EMERGENCY USE HOURS OF OPERATION
  - B. MAINTENANCE AND TESTING HOURS
  - OTHER OPERATING HOURS (DESCRIBE THE REASON FOR THE OPERATION)

IN ADDITION, EACH TIME THE ENGINE IS STARTED MANUALLY, THE LOG SHALL INCLUDE THE DATE OF OPERATION AND THE TIMER READING IN HOURS AT THE BEGINNING AND END OF OPERATION. THE LOG SHALL BE KEPT FOR A MINIMUM OF THREE CALENDAR YEARS PRIOR TO THE CURRENT YEAR AND BE MADE AVAILABLE TO DISTRICT PERSONNEL UPON REQUEST. THE TOTAL HOURS OF OPERATION FOR THE PREVIOUS CALENDAR YEAR SHALL BE RECORDED SOMETIME DURING THE FIRST 15 DAYS OF JANUARY OF EACH YEAR.

11. THE OPERATION OF THE ENGINE BEYOND THE 50 HOURS PER YEAR ALLOTTED FOR ENGINE MAINTENANCE AND TESTING SHALL BE ALLOWED ONLY DURING EMERGENCIES RESULTING IN AN INTERRUPTION OF SERVICE OF THE PRIMARY POWER SUPPLY OR DURING STAGE II OR III ELECTRICAL EMERGENCIES DECLARED BY THE ELECTRICAL GRID OPERATOR. THIS ENGINE MAY BE USED AS PART OF AN INTERRUPTIBLE ELECTRIC SERVICE PROGRAM.

# EXECUTIVE DEPARTMENT STATE OF CALIFORNIA

### PROCLAMATION OF A STATE OF EMERGENCY

WHEREAS on September 5, 2024, the Line Fire began burning in San Bernardino County and has since burned over 7,000 acres; and

**WHEREAS** the Line Fire has prompted evacuation orders and road closures, and continues to threaten structures, homes, critical infrastructure, endangered species, watersheds, and cultural and heritage resources; and

WHEREAS continued high temperatures throughout the day and night, dry conditions, and strong winds have increased the intensity and spread of the Line Fire, causing imminent threat to life, with an Excessive Heat Warning in effect in San Bernardino County; and

WHEREAS in response to a request from the Office of Emergency Services, the Federal Emergency Management Agency approved a Fire Management Assistance Grant to assist with the mitigation, management, and control of the Line Fire; and

**WHEREAS** under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to the Line Fire in San Bernardino County; and

**WHEREAS** under the provisions of Government Code section 8558(b), I find that the conditions caused by the Line Fire, by reason of their magnitude, are beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

**WHEREAS** under the provisions of Government Code section 8625(c), I find that local authorities are inadequate to cope with the magnitude of the damage caused by the Line Fire; and

**WHEREAS** under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of the Line Fire.

NOW, THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, HEREBY PROCLAIM A STATE OF EMERGENCY to exist in San Bernardino County due to the Line Fire.

### IT IS HEREBY ORDERED THAT:

 All agencies of the state government utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all residents are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.

- The Office of Emergency Services shall provide assistance to local governments, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.
- 3. As necessary to assist local governments and for the protection of public health and the environment, state agencies shall enter into contracts to arrange for the procurement of materials, goods, and services necessary to quickly assist with the response to and recovery from the impacts of the Line Fire. Applicable provisions of the Government Code and the Public Contract Code, including but not limited to travel, advertising, and competitive bidding requirements, are suspended to the extent necessary to address the effects of the Line Fire.
- 4. The California National Guard may be mobilized under Military and Veterans Code section 146 to support disaster response and relief efforts, as directed by the Office of Emergency Services, and to coordinate with all relevant state agencies and state and local emergency responders and law enforcement within the impacted areas. Sections 147 and 188 of the Military and Veterans Code are applicable during the period of participation in this mission, exempting the California Military Department from applicable procurement rules for specified emergency purchases, and those rules are hereby suspended.
- 5. The provisions of Unemployment Insurance Code section 1253 imposing a one-week waiting period for unemployment insurance applicants are suspended as to all applicants who are unemployed as a direct result of the Line Fire in San Bernardino County and apply for unemployment insurance benefits during the time period beginning September 5, 2024, and ending on the close of business on March 5, 2025, in San Bernardino County and who are otherwise eligible for unemployment insurance benefits.
- 6. In order to ensure hospitals, clinics, and other health facilities remain open, the Director of the California Department of Public Health (CDPH) may waive any of the licensing requirements of Chapters 1, 2, 8, and 8.5 of Division 2 of the Health and Safety Code and accompanying regulations with respect to any hospital, clinic, other health facility, home health agency, or hospice agency identified in Health and Safety Code sections 1200, 1250, 1727, or 1746 that is impacted by the Line Fire. Any waiver shall include alternative measures that, under the circumstances, will allow the facilities to remain open while protecting public health and safety. Any health facilities or agencies being granted a waiver shall be established and operated in accordance with their disaster and mass casualty plan or emergency preparedness plan. Any waivers granted pursuant to this paragraph shall be posted on the CDPH website and shall be in effect only so long as necessary to address the direct impacts of the Line Fire in San Bernardino County.

- 7. In order to directly respond to the needs of impacted adult and senior care facilities, child care facilities, children's residential facilities. resource family homes, home care organizations, and other similar care facilities and care providers within the California Department of Social Services' (CDSS) jurisdiction, the Director of CDSS may waive any provisions of the Family Code, Health and Safety Code, or Welfare and Institutions Code, and accompanying regulations or written directives, with respect to the use, licensing, certification, registration or approval of care providers, facilities or homes within CDSS jurisdiction set forth in the California Community Care Facilities Act (Health and Safety Code section 1500 et seq.), Child Care Provider Registration (Health and Safety Code section 1596.60 et seq.), the California Child Day Care Facilities Act (Health and Safety Code section 1596.70 et seq.), Residential Care Facilities for Persons With Chronic Life-Threatening Illness (Health and Safety Code section 1568.01 et seq.), the California Residential Care Facilities for the Elderly Act (Health and Safety Code section 1569 et seq.), Medical Foster Homes for Veterans (Health and Safety Code section 1568.21 et seq.), Continuing Care Contracts (Health and Safety Code section 1770 et seg.), the Home Care Services Consumer Protection Act (Health and Safety Code section 1796.10 et seq.), and the Resource Family Approval Program (Welfare and Institutions Code section 16519.5 et sea.). Any waivers granted pursuant to this paragraph shall be posted on the CDSS website and shall be in effect only so long as necessary to address the direct impacts of the Line Fire in San Bernardino County.
- 8. In order to directly respond to the needs of behavioral health programs and facilities impacted by the Line Fire, including alcohol and other drug programs, adult alcoholism or drug abuse recovery or treatment facilities, driving-under-the-influence programs, narcotic treatment programs, psychiatric health facilities, mental health rehabilitation centers, social rehabilitation programs, skilled nursing facilities with special treatment programs, Lanterman-Petris-Short designated facilities, community treatment facilities, short term residential therapeutic programs, and children's crisis residential programs, the Director of the Department of Health Care Services (DHCS) may waive any licensing, certification, or approval requirements for such programs under its jurisdiction set forth in Welfare and Institutions Code, Divisions 4, 5 and 9 and in Health and Safety Code, Divisions 2 and 10.5, and accompanying regulations, written standards, or information notices. Any waivers granted pursuant to this paragraph shall be posted on the DHCS website and shall only be in effect so long as necessary to address the direct impacts of the Line Fire in San Bernardino County.
- 9. Health and Safety Code sections 103525.5 and 103625, and Penal Code section 14251, requiring the imposition of fees, are suspended with regard to any request for copies of certificates of birth, death, marriage, and dissolution of marriage records, by any individual who loses such records as a result of the Line Fire in San Bernardino County. Such copies shall be provided without charge.

I FURTHER DIRECT that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the

State of California, its agencies, departments, entities, officers, employees, or any other person.
