


JUSTICE



ZERO EMISSION (ZE) BUS ROLLOUT

- Converting our fleet from CNG and near-zero CNG emission buses to zero emission electric buses to reduce emissions.
 - Compressed natural gas - .2 grams of nitrogen oxides/brake horsepower hour
 - Near-zero emissions engines - .02 grams of nitrogen oxides/brake horsepower hour
 - Electric buses - 0 grams of nitrogen oxides/brake horsepower hour



LANZAMIENTO DE AUTOBUSES DE CERO EMISIONES

- Convertir autobuses a GNC y a GNC de emisiones casi nulas en autobuses eléctricos de cero emisiones para reducir las emisiones.
 - Gas natural comprimido: 0,2 gramos de óxidos de nitrógeno/hora de potencia de frenado
 - Motores con emisiones cercanas a cero: 0,02 gramos de óxidos de nitrógeno/hora de potencia de frenado
 - Autobuses eléctricos: 0 gramos de óxidos de nitrógeno/hora de potencia de frenado



ZERO EMISSION (ZE) BUS ROLLOUT

- ZE purchases are being phased in as buses are replaced at 12 years of age.
- Going beyond the CARB Innovative Clean Transit (ICT) mandate, applying for grant funds to purchase higher % ZE than required:
 - 25% of new bus purchases ZE starting in 2023
 - 50% of new bus purchases ZE starting in 2026
 - 100% of new bus purchases ZE starting in 2029
 - 100% of buses ZE by 2040



LANZAMIENTO DE AUTOBUSES DE CERO EMISIONES

- Las compras de autobuses con cero emisiones se están realizando gradualmente a medida que se reemplazan los autobuses a los 12 años.
- Yendo más allá del mandato de Transporte Limpio e Innovador (ITC) de CARB, solicitando fondos de subvención para comprar un porcentaje de autobuses con cero emisiones mayor que el requerido:
 - 25% de las compras a partir de 2023
 - 50% de las compras a partir de 2026
 - 100% compras a partir de 2029
 - Autobuses 100% cero emisiones para 2040



ZERO EMISSION PROJECTS

- First 4 battery electric buses in operation since 2021 – 2 out of San Bernardino facility, 2 out of Montclair.
- State Clean Mobility Options grant – plug-in hybrid minivans operating OmniRide Bloomington service since 2022.
 - MSRC grant to expand early morning, evening, and weekend hours on OmniRide Bloomington service, will be zero-emission Ford e-Transit vans (on order), expected to start operations August 2024.
- Federal Low or No Emissions grant.
 - 4 fuel cell buses, currently on order, expected to start service by 2025.
 - Assessing options for fueling.
 - Workforce development training and Apprenticeship Program.

PROYECTOS DE AUTOBUSES CERO EMISIONES

- Primeros 4 autobuses eléctricos de batería en funcionamiento desde 2021: 2 en las instalaciones de San Bernardino y 2 en Montclair.
- Subvención estatal para opciones de movilidad limpia: minivans híbridas enchufables que operarán el servicio OmniRide Bloomington a partir de 2022.
 - La subvención de MSRC para ampliar los horarios de las primeras horas de la mañana, la tarde y los fines de semana en el servicio OmniRide Bloomington serán camionetas Ford e-Transit de cero emisiones (bajo pedido), que se espera que comiencen a operar en agosto de 2024.
- Subsidio federal de bajas o nulas emisiones ("Low-No").
 - Se espera que cuatro autobuses de pila de combustible, actualmente encargados, entren en servicio en 2025.
 - Evaluación de opciones de suministro de combustible.
 - Programa de aprendizaje y capacitación para el desarrollo de la fuerza laboral.

ZERO EMISSION PROJECTS

- Applying for grants to convert sbX Green Line in San Bernardino and Loma Linda to battery electric buses in 2026-2027.
- Chargers at Palm/Kendall station and at maintenance facility in San Bernardino.



PROYECTOS DE AUTOBUSES CERO EMISIONES

- Solicitar subvenciones para convertir sbX Green Line en San Bernardino y Loma Linda en autobuses eléctricos de batería en 2026-2027.
- Cargadores en la estación Palm/Kendall y en las instalaciones de mantenimiento en San Bernardino.

ABOUT ARROWHEAD REGIONAL MEDICAL CENTER

Arrowhead Regional Medical Center (ARMC) is a 456-bed university-affiliated teaching hospital and the Safety Net provider for San Bernardino County.

Owned and operated by San Bernardino County and governed by its Board of Supervisors, ARMC operates the Edward G. Hirschman Regional Burn Center, a level I trauma center, a comprehensive stroke center, a behavioral health center, and five primary care centers, over 40 outpatient specialty care services and a new integrated community health program focusing on connecting care outside of ARMCs campus.

Additionally, as a teaching hospital, ARMC is home to a robust graduate medical education program with over 200 medical residents and fellows across multiple medical and surgical specialties.



INTEGRATED COMMUNITY HEALTH

Serving the largest geographic county in the continental United States with over 20,000 square miles, ARMC's goal is to provide primary and specialty care services and be a resource for complex medical care to our residents throughout the entire county.

MOBILE MEDICINE

As part of our mission, the Mobile Medical Clinic offers a variety of healthcare services in underserved neighborhoods and remote areas of San Bernardino County.

The patient-centered mobile clinic is a model of care focused on the health of the community.

ARMC currently operates three medical mobile units, one for primary care and two Breathmobiles™ for Pediatric Asthma Services.

The Mobile Medicine Clinic for primary care offers the following services:

- Immunizations
- Diabetes education and care
- Family Planning
- Mammograms
- Pap Smears
- Patient Education
- Referral Services

MOBILE MEDICINE

The Breathmobile™ is a community outreach program that treats children with asthma and/or allergies. The fully equipped vehicles are staffed by physicians and a healthcare team that specializes in treating asthma and allergies.

The Breathmobile clinics offers the following services:

- Physical Exam
- Pharmacological Therapy
- Patient and Family Education on Asthma Management



DIGITAL & TELE-HEALTH

Digital Health encompasses a wide range of technology to improve health outcomes, reduce re-admissions, increase access and much more.

- Telehealth
 - Virtual Visits
 - Provide primary and specialty care visits remotely, allowing patients in remote areas to access the expert clinical services at ARMC
 - Access 24/7
 - Through [MyChart](#) patient can schedule select appointments, re-fill prescriptions, review their lab results and email with their care team 24/7.
- Remote patient monitoring
 - Hypertension- blood pressure
 - Diabetes-blood glucose
 - Pulmonary function-spirometer
- **More to come in the new future as ARMC continues to explore new Digital Health platforms**



STREET MEDICINE

ARMC's newest program, Street Medicine at Arrowhead Regional Medical Center is just getting started.

In 2023, the number of residents experiencing homelessness was reported as 4,195 for the county, which is a 26% increase from 2022. The ARMC Street Medicine teams' goal is to provide health care, community outreach and resources to those unsheltered county residents.

In partnership with the Department of Behavioral Health's InnRoads program, ARMC's Street Medicine program will be comprised of a physician, nurse and community health worker. Our goal is to provide primary and preventative medicine to our homeless populations on their turf.

This program is currently still in development; however, ARMC is in discussions with expositing programs and community organizations to align services and access to both primary and specialty care medical services.













Anticipated vs Earned WAIRE Points


Anticipated vs Earned Operator-Reported WAIRE Menu Items





by Item in 2021













Percentage of Warehouse Operators Who Paid Mitigation Fees






