Reissued SELA Green Space Program RFP Timeline

Spring 2021

- Community Steering Committee (CSC) participatory budgeting feedback collected
- CSC allocated \$2.5 million in Community Air Protection (CAP) Incentives for green space projects

Mid 2021 – Mid 2023

- Feedback and information collected through meetings and surveys with CSC members, community organizations, and agencies

Late 2023

- Submitted Project Plan to CARB

- Initial Green Space Program RFP approved by South Coast AQMD Board and released on February 2

Reissuing SELA Green Space Program RFP

- RFP initially released from February 2, 2024 – May 3, 2024
 - No applications received
- Summer 2024:
 - Feedback sought from interested parties about why they did not apply (summarized in table)
 - Met with multiple organizations to spread awareness of RFP
- Reissued RFP on September 6, 2024

- On September 6, 2024, the Board approved the AB 617 Public School Air Filtration Program
- Public schools and school districts located within AB 617 Communities and their vendors are eligible to apply for:
 - High Efficiency Particulate Air (HEPA) filtration systems, and
 - Replacement filters



- Up to \$13.7 million in Community Air Protection incentive funds is available for the installation and/or maintenance of HEPA filtration systems
- Staff has conducted outreach to eligible school districts and vendors
- Applications are due by 3 pm on December 20, 2024
- Staff anticipates to begin awarding contracts in Spring of 2025

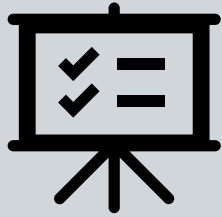

Reduce Emissions from General Industrial Facilities, SELA-5g-01B



Objective

Work with the CSC and local agencies to identify industrial facilities of concern in SELA, provide a list of South Coast AQMD rules, provide a three year compliance history of the facilities, summarize available emissions data and air monitoring data collected at or near facilities, and other sources of information, and update the CSC



Metrics

- (1) Work with CSC and local agencies to identify facilities of concern;
- (2) Create list of rules, compliance history, emissions data;
- (3) Compile monitoring data;
- (4) Report information to CSC

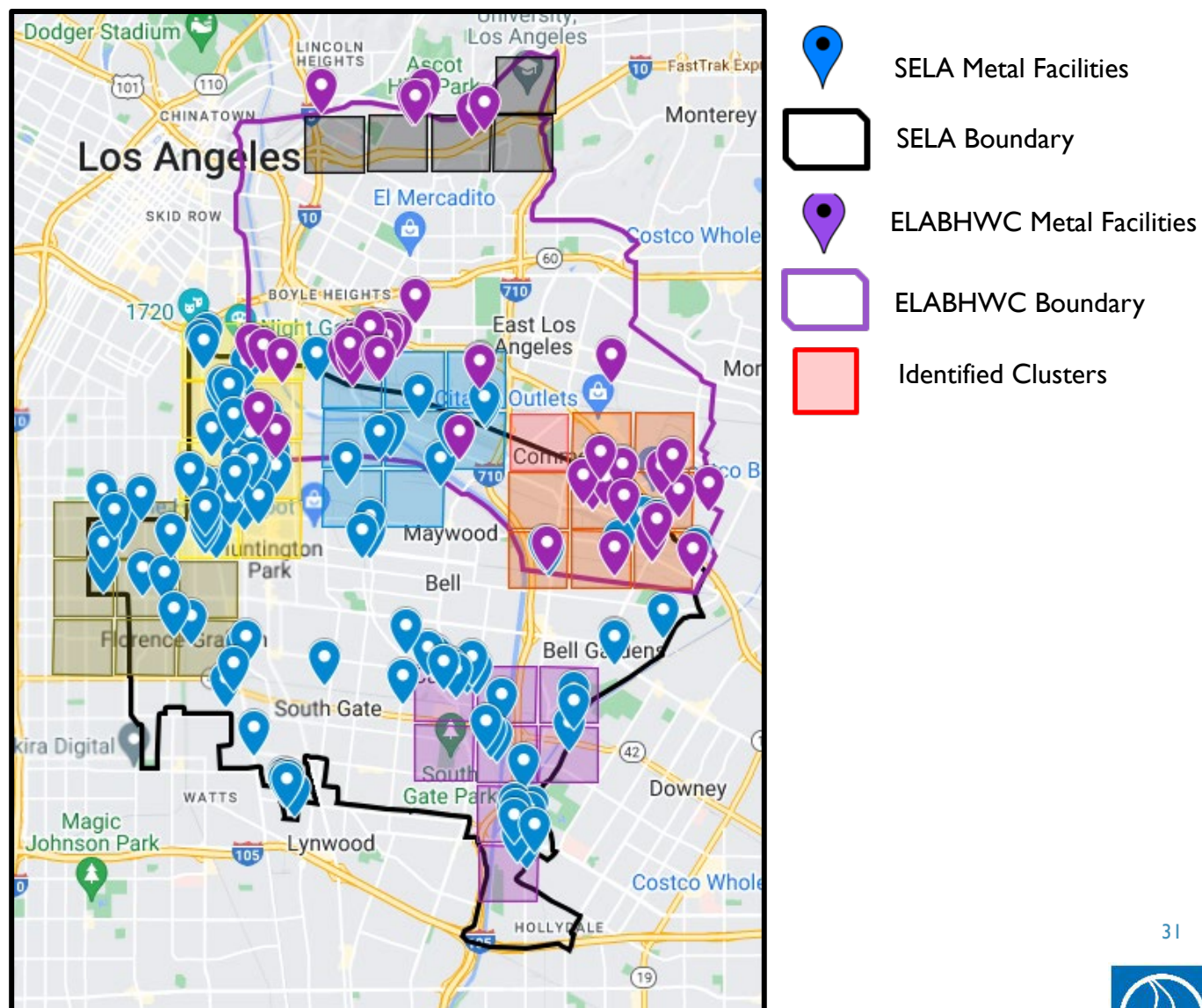
Multi-Metal Mobile Platform (MMMP) developed by South Coast AQMD

~ 240 hours of measurements within the two communities



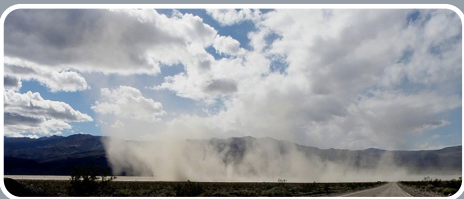
GENERAL OBSERVATIONS



Elevated levels of metals were observed near some clusters of metal processing facilities



Consistent elevated levels of metals were observed on freeways, major roadways, and on- and off-ramps



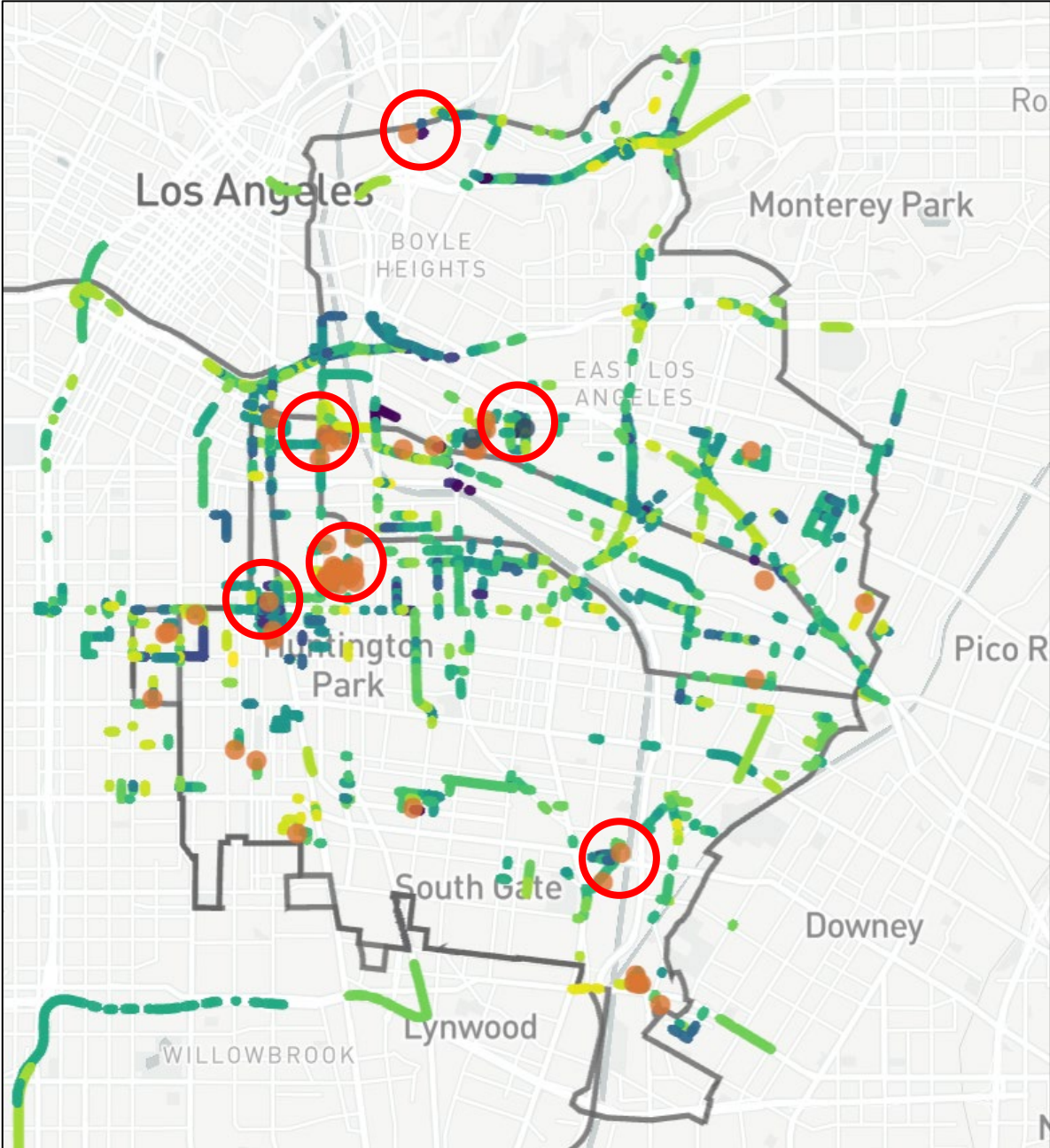
Elevated levels of mineral dust tracers highlight the impact of resuspended dust

○	Areas were also prioritized for follow-up stationary measurements

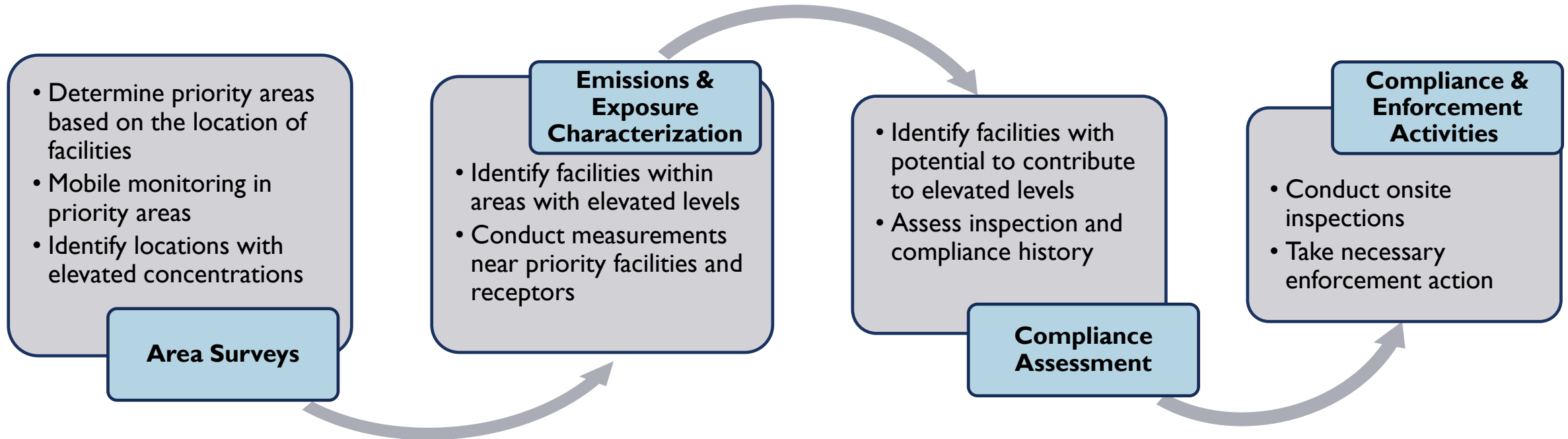

U.S. EPA Waivers & Authorizations

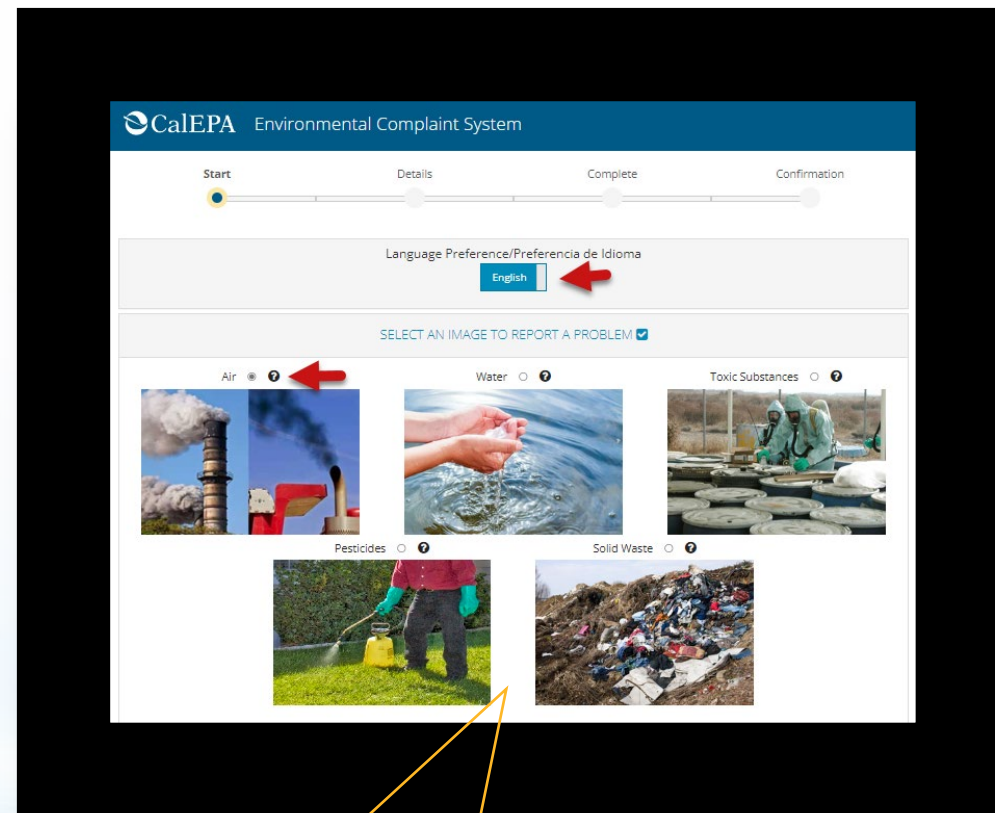
- After CARB adopts a regulation for an emissions standard for new motor vehicles, CARB requests a waiver or authorization from the U.S. Environmental Protection Agency (EPA) under the U.S. Clean Air Act.
- CARB generally does not enforce a regulation with a pending waiver or authorization request until the EPA approves the request or determines a waiver or authorization is not necessary.
- The table to the right are the regulations cited in Southeast Los Angeles CERP that are currently under U.S. EPA review.

Idling Reduction Materials

Continue to distribute truck idling reduction materials during inspections

Diesel-fueled trucks and buses can idle for **up to 5 minutes**, and for longer if they are Clean Idle certified.



Trucks cannot idle for more than 5 minutes within 100 feet of **restricted areas**.

- When queuing in line
- Using power take-off devices
- In emergency situations (e.g., adverse weather conditions or mechanical failures)

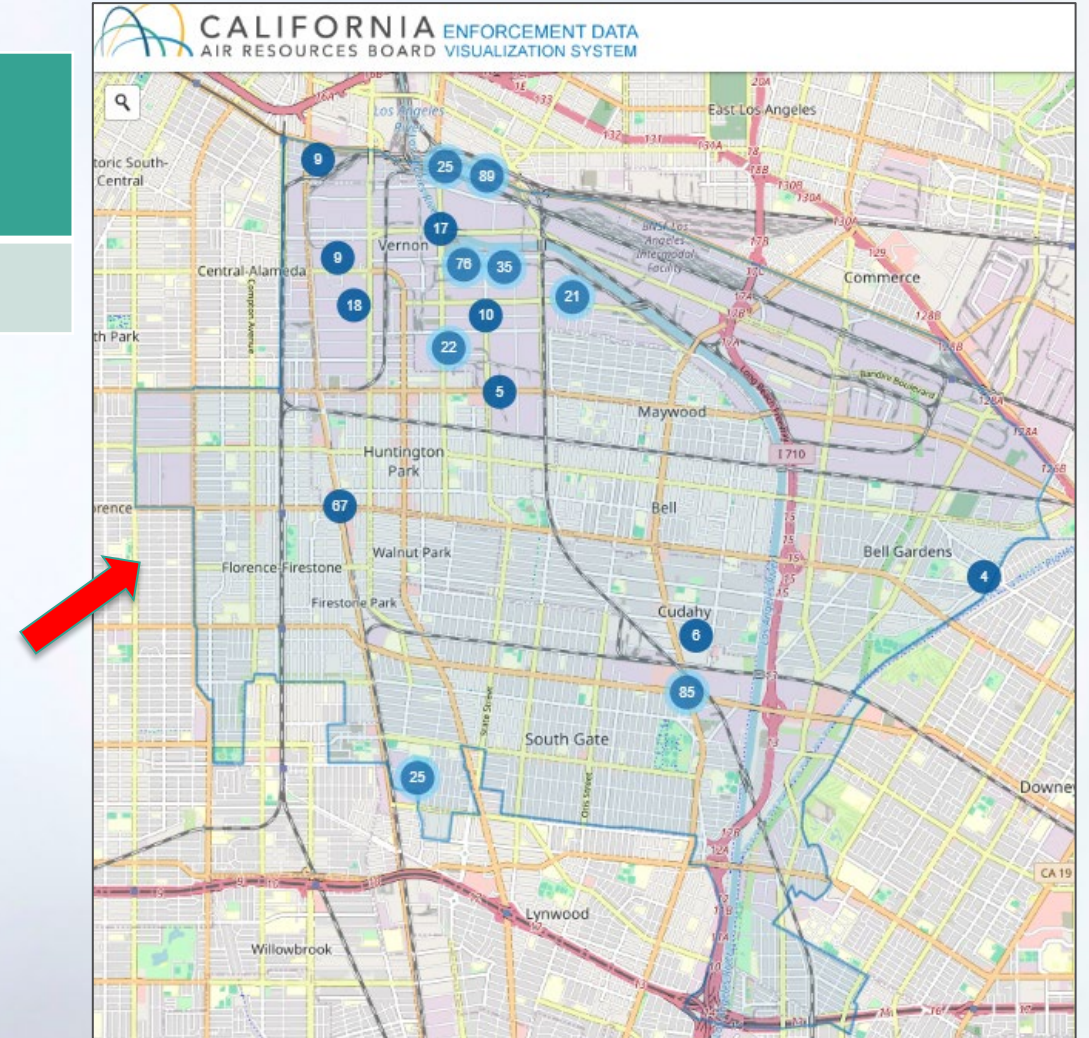

Catalytic Converter Theft Deterrence


Communities throughout California, and the country, are facing a significant increase in catalytic converter theft. The National Insurance Crime Bureau tracked a four-fold increase in monthly thefts, and LAPD saw more than a 300 percent increase from 2019 to 2020.

Why are catalytic converters being stolen?

They contain valuable precious metals like palladium, platinum, and even rhodium, which can cost upwards of \$15,000 an ounce.

Why is it important to have a catalytic converter?

They reduce harmful emissions from vehicles to help meet clean air standards. Chemical reactions take place inside the catalytic converter to change unhealthy vehicle exhaust emissions into less harmful ones.





What do I do if my catalytic converter is stolen?


Call the police immediately instead of engaging a thief that is stealing your catalytic converter. If you notice it has been stolen, contact law enforcement and your insurance provider, and have a trusted mechanic inspect the other exhaust components for damage before replacing your vehicle's catalytic converter.


Potential deterrents


It only takes a thief a few minutes to steal a catalytic converter, and it can happen at any time of the day or night. The best deterrent is parking your car in a garage, if possible.

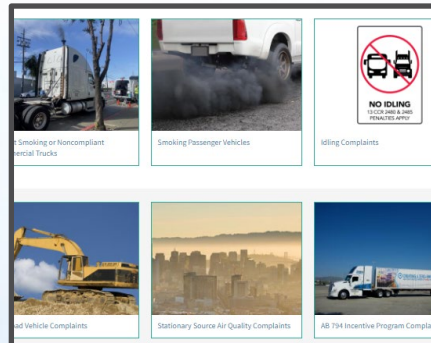

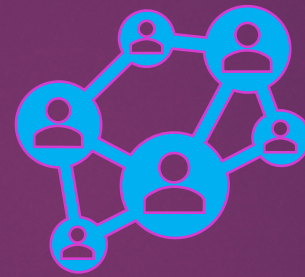

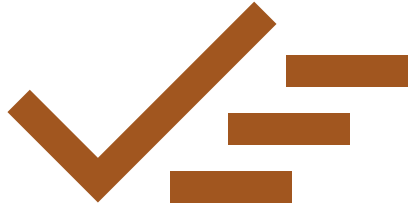
