## Review of the Draft Mitigated Negative Declaration (MND) for NG-13-406-PL (ENV 2013-1441) Project

The South Coast Air Quality Management District (SCAQMD) staff appreciates the opportunity to comment on the above-mentioned document. The following comment is intended to provide guidance to the lead agency and should be incorporated into the final CEQA document as appropriate.

Based on page 25 of the Draft MND the proposed project will require excavation and export of 44,000 cubic yards of soil from the project site that is surrounded by sensitive land uses (i.e., residential uses). However, the Draft MND did not evaluate any potential localized or regional air quality impacts from construction of the proposed project. As a result, the lead agency has not demonstrated that the project will result in less than significant air quality impacts during construction. Therefore, the SCAQMD staff recommends that the lead agency revise the air quality analysis to include an assessment of potential regional and localized air quality impacts during construction of the proposed project. These potential air quality impacts should be assessed using SCAQMD's Regional and Localized Significance Methodology and compared to the appropriate significance thresholds<sup>2</sup>. Further, the lead agency should ensure that all future projects include a regional and localized air quality analysis if warranted. In the event that the lead agency determines the proposed project will result in significant construction-related air quality impacts the SCAQMD staff recommends that the lead agency require mitigation to minimize these impacts to a less than significant level.
