## <u>Mitigated Negative Declaration (MND) for the Proposed</u> <u>Northrop Grumman Lab Expansion Project</u>

The South Coast Air Quality Management District (SCAQMD) staff appreciates the opportunity to comment on the above-mentioned document. The following comments are meant as guidance for the Lead Agency and should be incorporated into the Final MND.

## SCAQMD Staff's Summary of Project Description

The Lead Agency proposes to construct six separate additions totaling approximately 150,500 square feet (five laboratory buildings and lobby) to the existing M1 and M2 laboratory buildings on 13 acres within the 107-acre Northrop Grumman's Space Park campus (Proposed Project). The proposed building additions would include new manufacturing and test bays with new offices, labs, and control rooms. Approximately 3,525 square feet of M1 and M2 Buildings will be demolished.

## **SCAQMD** Rules and Permit

Since the Proposed Project would involve demolition, SCAQMD staff recommends that the Lead Agency include a discussion in the Final MND to demonstrate compliance with SCAQMD Rule 1403 – Asbestos Emissions from Demolition/Renovation Activities. Additionally, since the Proposed Project would include new manufacturing and test bays to renovate and modernize an existing aerospace laboratory, SCAQMD Rule 1124, Aerospace Assembly and Manufacturing Operations, may be relevant and applicable to the operation of the Proposed Project. In such case, the Lead Agency should include a discussion in the Final MND to demonstrate compliance with SCAQMD Rule 1124. In the event that the Proposed Project requires a permit from SCAQMD, SCAQMD should be identified as a Responsible Agency for the Proposed Project in the Final MND.
