## **Draft Preliminary Endangerment Assessment (PEA) and Proposed Land Use Covenant for American Metal Recycling**

South Coast Air Quality Management District (South Coast AQMD) staff appreciates the opportunity to provide comments on the above-mentioned document. The Department of Toxic Substances Control (DTSC) is developing cleanup actions to remediate soil contaminated with polychlorinated biphenyls (PCBs) and establishing a land use covenant to restrict future land uses to commercial and industrial uses on a 10-acre site (site). The site is located at 11150 Redwood Avenue near the northeast corner of Cherry Avenue and Jurupa Avenue in the City of Fontana. PCBs are an applicable toxic air contaminant listed in South Coast AQMD Rule 1466 – Control of Particulate Emissions from Soils with Toxic Air Contaminants<sup>1</sup>. Therefore, it is recommended that the Final PEA include clarification on whether DTSC, or other agencies listed in 1466(b), have designated, or plan to designate, the cleanup site for the contaminants listed as of concern. Additionally, if the site is so designated and thus subject to South Coast AQMD Rule 1466 requirements, it is recommended that applicable Rule 1466 requirements be incorporated into the cleanup plan. The Final PEA should also ensure that the cleanup actions will comply with South Coast AQMD Rule 403 – Fugitive Dust<sup>2</sup>.
