## **Draft Remedial Action Workplan (RAP) for Former Westinghouse Facility**

South Coast Air Quality Management District (South Coast AQMD) staff appreciates the opportunity to provide comments on the above-mentioned document. Based on the Community Update, the Department of Toxic Substances Control (DTSC) is proposing to install and operate a soil vapor extraction (SVE) system to clean up soil contaminated with volatile organic compounds (VOCs) on a 7.26-acre site (Site). The Site is located at 18020 South Santa Fe Avenue on the northeast corner of Santa Fe Avenue and East Harcourt Street in the community of Rancho Dominguez within Los Angeles County and the designated AB 617 Wilmington, Carson, West Long Beach community.

Due to the presence of VOCs in soil, requirements of South Coast AQMD Rule 1166 – Volatile Organic Compound Emissions from Decontamination of Soil<sup>1</sup> will apply and should be discussed in Final RAP. A Rule 1166 compliance plan will be required. Additionally, since the proposed remedial actions would involve the installation and use of a SVE system, complete and timely permit applications for a Permit to Construct and a Permit to Operate for the SVE system will be required under South Coast AQMD Rule 201 – Permit to Construct<sup>2</sup> and Rule 203 – Permit to Operate<sup>3</sup>.
