PREFACE

This document constitutes the Final Negative Declaration (ND) for the Shell Wilmington Refinery Rule 1105.1 Compliance Project. The Draft ND was circulated for a 30-day public review and comment period (March 1, 2006 through March 30, 2006). No comment letters were received during the public comment period. Minor modifications have been made to the Draft ND such that it is now a Final ND. Further, the project description in the Final ND was modified from that in the Draft ND due to some changes proposed by the applicant. The proposed project changes were evaluated and minor modifications have been made to the Draft ND. None of the modifications alter any conclusions reached in the Draft ND, nor provide new information of substantial importance relative to the draft document that would require recirculation of the Draft ND pursuant to CEQA Guidelines §15073.5. Therefore, this document is now a Final ND. Additions to the text of the ND are denoted using italics. Text that has been eliminated is shown using strike outs.
