Re: Submittal of 2016 Air Quality Management Plan

Dear Mr. Corey:

At its March 3, 2017 meeting, the South Coast Air Quality Management District (SCAQMD) Governing Board adopted the 2016 Air Quality Management Plan (AQMP or Plan). The 2016 AQMP, as approved, is submitted as part of the California State Implementation Plan (SIP). The Plan addresses the following National Ambient Air Quality Standards (NAAQS) for South Coast Air Basin:

- 2012 Annual PM_{2.5} NAAQS (12 $\mu\text{g}/\text{m}^3$) with request for reclassification to serious nonattainment area for attainment by 2025
- 2008 8-hour Ozone NAAQS (75 ppb) with attainment demonstration by 2031
- 2006 24-hour PM_{2.5} NAAQS (35 $\mu\text{g}/\text{m}^3$) with attainment demonstration by 2019
- 1997 8-hour Ozone NAAQS (80 ppb) with attainment demonstration by 2023
- 1979 1-hour Ozone NAAQS (120 ppb) with attainment demonstration by 2022

The 2016 AQMP also demonstrates attainment of the 2008 Ozone Standard in Coachella Valley by 2026. The Plan also demonstrates compliance with all applicable Federal Clean Air Act requirements pertaining to nonattainment areas pursuant to the U.S. Environmental Protection Agency (EPA) approved Implementation Rules, such as the annual average and summer planning emission inventory for criteria and precursor pollutants, attainment demonstrations, reasonably available control measure (RACM) and reasonably available control technology (RACT) analyses, reasonable further progress (RFP), PM precursor requirements, vehicle miles traveled (VMT) demonstrations, and transportation conformity budgets for the South Coast Air Basin and Coachella Valley.


