PURPOSE OF THE MEETING

The South Coast Air Quality Management District (South Coast AQMD) has scheduled a Public Consultation Meeting and a Public Workshop for the purpose of soliciting information, comments, and suggestions from the public, affected businesses, and stakeholders regarding the Coachella Valley Extreme Area Plan (Plan) for the 1997 8-hour ozone National Ambient Air Quality Standard (NAAQS) and Proposed Amended Regulation XIII – New Source Review, Regulation XX – Regional Clean Air Incentives Market, and Regulation XXX – Title V. The South Coast AQMD Governing Board will consider approval of the Coachella Valley Extreme Area Plan for the 1997 8-hour ozone standard and Proposed Amended Regulations XIII, XX, and XXX at the Public Hearing scheduled on Friday, December 4, 2020.

BACKGROUND

On July 10, 2019, the U.S. EPA granted a voluntary reclassification of the Coachella Valley Planning Area from “Severe-15” to “Extreme” for the 1997 8-hour ozone NAAQS, with an attainment date of June 15, 2024. A revision to the State Implementation Plan is required to address the requirements resulting from the U.S. EPA’s reclassification of the Coachella Valley to Extreme nonattainment status. The Coachella Valley Extreme Area Plan is being developed to bring the area into attainment as expeditiously as practicable and by the required attainment date. Exceedances of the ozone NAAQS in Coachella Valley are primarily due to the direct transport of ozone and its precursors from the South Coast Air Basin, which is located upwind of the Coachella Valley. While local emissions controls benefit Coachella Valley air quality, the area must rely on emission

controls being implemented upwind to demonstrate improved air quality and attainment of the federal ozone standard. Based on updated emissions inventory and air quality modeling, the Coachella Valley is expected to achieve the 1997 8-hour ozone NAAQS by the attainment date through continued implementation of existing rules and regulations. Other applicable federal Clean Air Act requirements are also presented in the Plan.

The objective of Proposed Amended Regulations XIII, XX, and XXX rules are to reduce the major polluting facility threshold definition for VOC and NOx emissions, which are precursors to ozone, from 25 tons per year to 10 tons per year. Amendments are also needed to reduce the major modification threshold definition at a major polluting facility from 25 tons per year to one pound per day of VOC or NOx emissions. Lowering the thresholds could result in additional permitting requirements for Coachella Valley facilities with a potential to emit of 10 tons or more per year of VOC or NOx emissions.

CALIFORNIA ENVIRONMENTAL QUALITY ACT

Pursuant to the California Environmental Quality Act (CEQA) and South Coast AQMD's certified regulatory program (Public Resources Code Section 21080.5, CEQA Guidelines Section 15251(l) and South Coast AQMD Rule 110), the South Coast AQMD, as lead agency, is reviewing the proposed project to determine if it will result in any potential adverse environmental impacts.
