## **Eaton and Palisades Air Monitoring Update**

**DIAMOND BAR** – The South Coast Air Quality Management District (South Coast AQMD) continues its expanded air monitoring efforts in response to ongoing debris removal efforts near the Eaton and Palisades fire areas. Air monitoring will provide data for particulate matter (PM2.5 and PM10), air toxics (such as lead and arsenic), and asbestos in communities near the burn zones.

The public within and near the Eaton and Palisades burn areas is strongly encouraged to follow the <u>safety</u> <u>precautions</u> outlined by the Los Angeles County Department of Public Health to minimize the potential risk of exposure to ash, soot, and fire debris. Strong winds can carry ash and soot over a wider area, increasing the potential for exposure, so it is especially important to take extra care during weather fluctuations and windy conditions.
