# BACKGROUND – AB 617 CERP MEASURES

## East Los Angeles, Boyle Heights, West Commerce (ELABHWC)

- CERP<sup>1</sup> includes an action to identify funding for residential air filtration systems in homes to reduce exposure to diesel PM
- In February 2021, the CSC allocated \$1.86M in CAPP funds toward residential air filtration systems

## Eastern Coachella Valley (ECV)

- CERP<sup>2</sup> includes six actions to install and maintain air filtration systems in homes to reduce exposure to dust from the Salton Sea
- In March 2021, the CSC allocated \$1M in CAPP funds toward residential air filtration systems for ECV community

# DEVELOPMENT OF RESIDENTIAL AIR FILTRATION PROGRAM

## ■ Request for Quotes (RFQ)

- Bulk purchase pricing for air filtration unit and three-year supply of replacement filters
- Leverage available funding to maximize the number of homes that receive air filtration
- Evaluation and selection criteria

## ■ Program Announcement (PA)

- Establishes program criteria:
  - Eligibility requirements
  - Funding limits
  - Approval process
- Application submittal instructions

## ■ RFQ and PA require Board approval

- Technology Committee – September 16, 2022
- Governing Board – October 7, 2022

# ELIGIBILITY AND FUNDING REQUIREMENTS

- **Minimum eligibility requirements:**

- Reside in the AB 617 ELABHWC or ECV Community
- Provide residence information (e.g., address and sq. ft. occupied by applicant)
- Air filtration units must be CARB certified\* and selected through RFQ
- Other administrative requirements

- **Funding amounts**

Type of Equipment	Funding Amount
Standalone Air Filtration Unit	Up to 100%
Replacement Filters (3 years)	Up to 100%

- Funding prioritized in ECV on first-come, first-served basis and ELABHWC on proximity to emissions sources

# KEY FUNDING AND BUDGET CONSIDERATIONS



- Residential Air Filtration Program to offer applicants a minimum of:
  - One portable air purification unit, and
  - A three-year supply of replacement filters per unit
- Units available for funding will be announced as a result of RFQ Process
- \$1,000 budget allocated for each address

# EXAMPLE – HONEYWELL TRUE HEPA AIR PURIFIER

## Honeywell True HEPA Air Purifier




- HEPA filtration captures the following microscopic airborne allergens and particles:
  - Dust, pollen, pet dander, dust mite debris and smoke
  - Filter replaced once per year
- Activated carbon pre-filter captures large airborne particles and reduces odors and VOCs
  - Requires replacing every 3 months
- Filter change indicator and reset
- Energy Star rated
- 4.8 air changes an hour in a 465 square foot room



# EXAMPLE – BLUEAIR CLASSIC 680I AIR PURIFIER

Blueair Classic 680i Air Purifier




- HEPA filtration captures airborne pollutants including:
  - Dust, mold, pet dander, and pollen
  - Dual protection filters with activated coconut carbon
  - Single filter needs replacing every 6 months
- Energy Star rated
- For large rooms between 700 square feet and 800 square feet






